



### VI-CHRIST IS RISEN

"We believe in the resurrection of the crucified body of our Lord."

The resurrection of Christ has been called the corner stone of the Christtian faith; and certainly the whole structure collapses if this can be proven false. The apostle Paul recognized this, and admitted the vanity of our faith "if Christ be not risen" (I Cor. 15: 12-19). Without the resurrection, we lack the supreme testimony to the deity of Christ (Rom. 1:4). Without the resurrection, all attempts to attach an atoning value to the death of Christ are futile. Without the resurrection, the present priestly work of Christ is pure fiction. Without the resurrection, death is not conquered, and the hope of immortality is wishful thinking.

Is it any wonder that the enemies of Christianity have so consistently trained their artillery on the resurrection of Christ? They have used all sorts of tactics, from the blustering denial of the infidel to the subtle softening of the doctrine by men in pulpits who have bewitched the unwary. But while those who do not want Christ embrace the arguments of unbelief, the evidences of the resurrection still challenge the reason and not least the evidence of lives that have been touched and transformed by the living Christ.

Now when we speak of the resurrection of Christ, we do not mean simply the survival of personality. We certainly believe that human personality persists in and after death, a fact which undergirds the doctrine of eternal destiny, in heaven or hell.



Nevertheless the appearings of the risen Christ to His disciples were something more than the impact of His continuing personality upon their clearing minds! He appeared in visible form, and, when the amazed disciples "supposed that they had seen a spirit." Jesus used every means available to demonstrate that He was before them in the very body in which he had been crucified and buried (Luke 24: 37-46). Neither a spirit nor a survived personality could show physical wounds or eat fish.

We reject also the groundless assertion of Jehovah's Witnesses that the body in which Jesus appeared after His death was a special creation for the moment, and dissipated into gases after each appearing. Was Jesus trying to fool His disciples? If Jesus, in the body of His humiliation, could slip through crowds of enemies unharmed, could walk on the stormy could radiate waters, heavenly brightness on the Mount of Transfiguration, surely, with the glory begun, He could appear and disappear, without respect to doors and bars!

With joy we accept the affirmation of the great apostle: "Now is Christ risen from the dead, and become the first fruits of them that slept" (I Cor. 15:20). This we believe.
